R25 billion for Waterberg development



President Cyril Ramaphosa is taking important steps to ensure that the communities of the Waterberg District Municipality receive water and infrastructure projects which are in line with the District Development Model.

President Cyril Ramaphosa has announced R25 billion for infrastructure projects in the Waterberg District Municipality in Limpopo.

The projects are expected to, among other things, address issues of severe water shortages in the district which is made up of the Bela-Bela, Lephalale, Modimolle-Mookgophong, Mogalakwena and Thabazimbi local municipalities.

Addressing residents at the Shongoane Sports Ground in Lephalale recently, the President said government would in the next five years complete the Moloko Water Resource Project.

During the period, government would also pursue the Waterberg rail-line and build several much-needed schools in various communities in the district.

"We know that the people of this district are confronted with severe unemployment and poverty. We know about the problems of water, electricity, sanitation and roads. We know about access to land," he said.

Government, he said, was also aware of the poor telecommunications network that frustrates economic development in the area.

"We need to attract investment in the area. We recently held the second SA Investment Conference and we raised R363 billion from private investment," he said.

A portion of that money was to be invested in the mining district.

"Government will invest R25 billion over the next five years, and that's a lot of money. Some companies will in this

Uqhawulo-mtshato ngokusemthethweni

Xa sele uzame yonke into ukwenza ukuba umtshato wakho usebenze, uqhawulo-mtshato lungayeyona nto ingcono kuni nobabini nomlingane wakho. Uqhawulo-mtshato lunzima kwaye luyadakumbisa kwii-ntsapho zibe nazo iinkqubo zomthetho ziyanza ingqondo iphixane.

Uqhawulo-mtshato kuxa umtshato uqhawulwe ngo-kusesikweni enkundleni ye-zomthetho. Kukho iindidi ezim-bini zoqhawulo-mtshato: olun-gaphikiswanga – apha bobabini abalingane bavumelanayo ukuba uqhawulo-mtshato kufanele luqhubeke; noluphikiswayo – apha abalingane bangavu-melaniyo ngoqhawulo-mtshato olo okanye bangavumelaniyo ngemiqathango yalo.

UJosephine Peta, noliGosa loLawulo lezoMthetho eliPhe-zulu kwi-Ofisi yeGqwetha leJaji eliJongene neMiba yeeNtsapho yeSebe lezobuLungisa noPhu-hiliso loMgaqo-siseko, ucacisa ukuba uqhawulo-mtshato luqala xa kukhutshwe iisamani.

"Umntu ofuna ukuba umtsha-to wabo uqhawulwe angafuma-na iisamani zoqhawulo-mtshato



kwinkundla ephakamileyo okanye kweyenqila, okanye unokuya kwigqwetha ukuba limncede kulo nkqubo. Lo mlingane ufaka isicelo sokuqala inkqubo yoqhawulo-mtshato ubizwa ngokuba ngummangali aze omnye umlingane abizwe ummangalelw," utshilo uPeta.

UPeta ucacise ukuba iisamani zoqhawulo-mtshato kufuneka:

- zichaze ukuba akukho themba lokuba ungaze uphinde ulungiseke lo mtshato,
 - zilungiselele ukohlulwa kwempahla ekuditye-nwego ngayo okanye unyanzeliso lwemimiselo ekuvunyelwenengayokwi-sivumelwano somtshato esatyikitywa ekuqlaweni
 - kwalo mtshato, zize zicacise ukuba ngawaphi amalungiselelo aza kwenziwa ngabantwana besi sibini, afana nokuba abantwana baza kuhlala kubani.
- "Iisamami kwakhona kufuneka zichaze ukuba lowo ungummangalelw uneentsuku ezi-10 zokuphendula iisamani – kwimeko apha bahlala khona kummandla omnye kunye nommangali, okanye iiantsuku ezingama-20 – ukuba bahlala kumaphondo awohlukeneyo," wongeze watsho uPeta.
- Xa sele livuliwe ityala, am-xwebhu abuyiselwa kumma-nngali, ekufanele eyokuwan-kezela kunothimba wendawo ahlala okanye asebenza kuyo

ummangalelw.

"Ngoko ke unothimba uza kusa la amaxwebhu kumma-nngalelw buqu aze akhuphe isiqinisekiso sokuba uwahambisile, ukuqinisekisa ukuba amaxwebhu asiwe. Kwimeko apha kuchaphazeleka khona aba-ntwana, i-Ofisi yeGqwetha leJaji eliJongene neMiba yeeNtsapho kufuneka yazisiwe," uphawule watsho uPeta.

Emva kwexesha leentsuku ezi-10 okanye ezingama-20, ummangali angalubhalisa uqhawulo-mtshato kumqu-lu wamatyala enkundla.

Ku qhawulo-mtshato oluphikiswayo, ummangalelw kufuneka ephendule iisamani ngokufaka isaziso se-njongo yokuphikisa uqhawulo-mtshato olo.

"Xa sele kwenzekile konke oko, kukwafuneka efake impendulo ayakuzithethelela ngayo phakathi kwexesha elicacisiwe. Le mpPENDULO yinkcazelu apha ummangalelw aphantula kuyo izityholo ezikwiisamani. Emva kokuba ifakiwe lo mpPENDULO, umma-nngali naye usenokuyiphendu-la lo mpPENDULO okanye afake isaziso sokumisela umhla wokuxoxa.

"Ke ngoku ityala liya ku-

miselwa umhla wokuxoxa," uqkumbele watsho uPeta.

Yintoni uqhawulo-mtshato oluzenzekelayo?

Inkundla iyakunikezela ngoqhawulo-mtshato oluzenzekelayo ukuba iisamani bezinikezelwe kumlingane aze ke angaphenduli phakathi kwexesha elimiselweyo. Kodwa ke, bubuchule ukuba uqhagamshelane naye umlingane wakho kuqala kuba usenokubuya eku-hambeni kwethuba azame ukuba sijikwe eso sigwebo soqhawulo-mtshato ngezi-zathu zokuba ebenesizathu esibambekayo esibangele ukuba aliphose ixesha elimiselweyo.

Certified documents now expire after six months

All government departments and its components have been directed to stop the practice of requiring certified copies of documents not older than three months to accompany applications for employment.

This decision follows complaints raised with President Cyril Ramaphosa on social media and through other channels about the requirements for compliance with public sector job applications.

Departments have been ad-

vised to at least accept certified copies of documents submitted with an application for employment that are up to six months old, in those cases where the document certified does not have an expiry date that falls within the six-month period, the Presidency said.

"Government has recognised that the practice to date impacts negatively on job seekers in the current economic climate in South Africa, and that there is a need to reduce the burden on job seekers to submit - with

each separate job application - certified copies of supporting documents (such as academic qualifications, which are not older than three months)," the Presidency said in a statement.

The Presidency said this change will also reduce the workload that the certification of documents creates for the South African Police Service personnel, who will now be able to devote more time to their core function of ensuring that South Africans are safe. Snews.gov.za
