Sikolwa lesisha semma- ngo waseMpumalanga



Sikolwa lesakhiwe ngalokusezingeni leisetulu iMakause Combined School singatsatsa bantfwana labangafika kulaba-1 200 sisePhola, eMpumalanga.

Noluthando Mkhize

Makause Combined School, lesePhola eMpumalanga, iletse litsembo emmangweni ngekucinisekisa kufinyelela imfundvo.

Lesikolwa lesakhiwe ngalokusezingeni leisetulu lesibita-R74 wetigidzi sibekhona ngenca yekubambisana emkhatsini weLitiko Letemfundvo Lesisekelo nenkampani yetimbiwa iGlencore.

Lesikolwa besiyincenyen yemklamo lo-mkhulu wekutfutfwa lapho khona iGlencore yatfutsa iminden le-120 yayisusa emaphandleni aseTweefontein yayiyisa ePhola, njengencenyen yeMkalamo yawo Wekutfutfukisa iTweefontein.

Loeklamo umele lutjalamali IweGlencore Iwa-R8 wetigidzigidzi, lolunetibenti letinge-780 leticashwe kwalomphelo, lokhicit emathani latigidzi letisiphohlongo temalahle latsengisekako njalo ngeomyaka. Ngesikhatsi kwakhiwa, lomkamo wadala ematfuba emisebenti lenge-

tulu kwale-2 600 nematfuba emabhizinisi lamanyenti abosomabhizinisi bendzawo ngekutsenga endzaweni.

Loeklamo ubuye ufake ekhatsi kwakhiwa kwetindlu, lokwabita tindleko letinge-R70 etigidzi, letingahlalisa imindenleyatutfwa letinganisewa kule-120.

KUBUYISA LITSEMA

Lesikolwa lesikolwesini wetindlu letakhiwako, ngesemabanga abokhewana, emabanga laphasi nemabanga laphakeme. Sinemakasi lange-32, emalabhowekhthi esayensi, sakhiwo sekufundisa imisebenti yasekhaya, umtapolwati, sikhungo sabongcondvomshini kanye nelihhola lelitsatsa bantfwana laba-1 200.

Amos Shali Mahlangu sewubenguthishelanhloko walesikolwa iminyala lenge-32 futsi usibone sitfutfuka ekuhambeni kweminyaka.

"Ngembii kwekutfutfwa, besihlala eTweefontein lebekungummamgo lolimako nalomba timbiwa. Loku-ke bekusho kutsi bantfwana bebadzinga kuhamba emabanga langetulu kwa-40 wemakhilomitha nabaya esikolweni, basebentisa sitfutsi labasinkwa Litiko Lete-

mfundvo Lesisekelo."

Njengobe manje sekwakhiwa lesikolwa netindlu bantfwana sebahamba libanga lelingaphasi kwelkhilomitha linye nabaya esikolweni.

"Yinye yetinkinga esikolweni lesidzala bekukulova kantsi futsi nebatli bebangeti emihlanganweni nganca yelbinga bekufanele kutsi balihambe. Kusukela satfutsa, lizinga lekulova selehlile kantsi futsi sebanengi nebatli labetako emihlanganweni,"

Phillip Maimela, sihlalo wemtimba lowengamele sikolwa, unebantfwana lababili lababafundzi kulesikolwa. Utsite siyamjabulisa lesikolwa lesisha kantsi futsi bantfwana bakhe batfola imfundvo lenguyona yona.

Indvuna yeTemfundvo Lesisekelo Angie Motshekga, lobekakhona nakuvulwa lesikolwa, utsite sitawutintintja kakhulu timphilo talabafundzi.

"Lutjalamali lolungaka kutemfundvo luhombisa kutinikela kweGlencore kulikusasa lalelive. Ngulapho sihlangana sonkhe ndzwononye singuhulumende, bosomabhizinisi, tinhlangano temmango lapho khona singa-khona kucedza tihibe tekungalingani.

Imisebenti, tindlu ne-temphilo telidolobho letimayini

Hulumende sewukhiphe-R18

wetigidzigidzi wekuphucula timo tekuhlala temimango yetimayini lephuyle kulo lonkhe lelive. Uhola Likomidi Letindvuna (i-MC) lelibukene nekutfutfukisa imimango yetimayini, lomklamo ufaka ekhatsi kwakhiwa kwetindlu nemklamo wetekuphila kahle.

"Sekukonkhe kukhishwe-R18 wetigidzigidzi temsebenti lochubekako wekutfutfukisa imimango yetimayini lehluphekako, lokuzuzisa letifundza letilandzelako: Mphumalanga, Kapa, Freystata, Gauteng, KwaZulu-Natal, Limpopo, Mpumalanga neNyakatfo Nshonalanga," kusandza kusho Mengameli Zuma.

Mengameli umemetele kutsi Litiko Leku-hlaliswa Kwebantfu, lisitwa ngema-ejensi, liphumelelisa umklamo wahulumende weti-ndlulutinge-66 kulamadolobha etimayini la-15 labekwe embili.

Ngemnyaka wetimali-2014/15, kucifwe imali lengetulu kwe-R419 wetigidzi kubhajethi lebekwe eceleni, ibekelwe kututfukisa tindzawo tekuhlala letingakahlelekiemadolobheni etimayini labekwe embili iLimpopo, iFresyistata, iGauteng, iMpumalanga neNyakatfo Nshonalanga.

Kubekwe imali lengabangu-R1 sigidzigidzi yalomnyaka wetimali. Kulindzelwe kutsi kwakhiwa ngayo tindlu leti-19 000 emadolobheni etimayini.

Kwengeta kulesibonelelo lesibekwe eceleni sekwakhiwa kwetindlu temadolobha etimayini laphuyle, i-ejensi yekwakhiwa kwetindlu yeLitiko Letekuhhlaliswa Kwebantfu selifake ngetulu kwa-R1 wesigidzigidzi ekuhlalisewi kwebantfu lokuhanganisiwe emadolobheni etimayini.

Mengameli Zuma utsite ematiko ahulumende lamanengi achuba imiklamo yetimboni letinkhulu naletincane emadolobheni etimayini la-15.

"Leti," kusho yena, "tibaluleke kakhulu ekwakheni emabhizinisi nematfuba emisebenti."

"Kute kutsi bantfwana basebente ngelizinga leisetulu, badzinga simondzawo lesivumako nesibafaka inshikelo futsi lesikolwa sitawuba kukhanya kwlitsembo," kwasho Indvuna Motshekga.

Mengameli Zuma ukhuluma netitjudeni

Ekvakasheni kwakhe lasandza ku-kwenta Mengameli Jacob Zuma utibonele yena ngekwakhe timo tekuphila tetitjudeni taseTshwane University of Technology, lemise enyakatfo yePitoli.

Lokuvakasha bekuyinceny yeSiyahlola, lokuluhlelo Lwekulandzelela IwaMengameli neluhlelo lwalo lweNyanga yeLusha, lolugcile ekutfutfukiseni temfundvo, emakhono ne-kwakha ematfuba emisebenti.

"Sitole tikhalo letivelu kuitjudeni mayelana nesimo sekuguga kwemakamelo eku-lala nemakamelo ekugezela endzaweni yekuhlala yalabasikati. Sitole tikhalo mayelana nemathaveni lasebenta ekungeneni ekhempasi, kungako-ke bekubalulekile kutsi ngite ngitibonele mine mattupha kutsi kwentekani,"

kwasho Mengameli Zuma.

Ukhulume netitjudeni waphindze futsi wa-hamba abuka tindzawo tekuhlala talabasikati nalabadvuna. Titjudeni tikhale ngetimo tekuhlala letimbi nekweswelakala kwekuvikeleka lokukahle.

Titjudeni tibuye taveta ludzaba lwekusitwa ngetimali tekukhokhela tifundvo tato, insa-yeya linyenti lelusha lalelive lelibukene nayo.

"Kuyasifokotisa kutsi bantu labasha balelive balambele imfundvo ngalendlela futsi singuhulumende sidzinga kutsi sibukane nalensayeya ngalokwakhako," kwasho Mengameli Zuma.

Lindokuhle Manne (loneminyaka le-18), sitjudeni lesenta umnyaka wekucala weluhlelo lwetifundvo teKuchumana kuteBhizini (i-Business Communication), utsite lokumkhsata kakhulu kusitwa ngetimali.

"Titjudeni letinengi atikhoni kufinyelela

Sikimu Selusito Lwetimali Setitjudeni Savelonkhe (i-NSFAS). Loku kunemtselela lomubi kakhulu kitsi," kwasho Manne.

LISONTFO IBETHESDA FOUNTAIN

Mengameli uphindze wavakashela Lisontfo iBethesda Fountain, leseyibe siphephelo setitjudeni lettingatfoli indzawo yekuhlala noma lettingakhoni kuhlala ekhempasi.

Lelisontfo lihlalisa titjudeni letinge-70. Lesinye saletitjudeni nguNkosingiphile Sibeko loneminyaka lenge-20 budzala.

"Emalunga alelisontfo abantu labakahle futsi kute lokunye lasikhombise kona ngaphandle kwemusa," kwasho Sibeko.

KUHLOMISA LUSHA EMA-KHONO

Indzawo yekugcina layivakashele Mengameli

kube yiBotho Socio-Psychology Centre, sikhungo lesitfutfukisa emakhono elusha lesatsatfwa ngulenyuvesi yasifaka ngaphasi kweluphiko lwayo.

"Kuleminyaka solo sabakhona lesikhungo sesite lasha lonyenti lwalommango kutsi lutfole emakhono latsite nekutsi bantjintje timphilo tabo ngekubasusa etitaladini futsi sibanike ematfuba ekutifutfukisa," kwasho Umphatsi waleSikhungo Stevens Lodi.

Lesikhungo, lesifundzisa tinhlelo tetifundvo letehlukene, sisita ngetimali Litiko Letekutfutfukisa Kwetenhlalakahle futsi siniketa lasha lolusemkhastini weminyaka yebudzala le-18 nalenge-35 tinsita.

Comfort Mnisi (loneminyaka lenge-21) lofike kulesikhungo ekucaleni kwalomnyaka futsi sewuphotfule luhlelo lwetifundvo tekutfutfukisa emakhono etenhlalakahle futsi kwanmanje uceceshelwa emakhono ekusebentisa ngcondvomshini.

"Ngembu kwekutsi ngite eBotho bengingenti lutfo. Manje senginenhoso emphilweni futsi ngalamakhono lengiwatfole lapha ngitawukwati kuchubekela embili nemphilo," kwasho Mnisi.



Kulwisanaya mayelana nelilungelo lekugcinwa kwebantfwana, tincabano nemacala ekungelela nekuntjontjwa k webantfwana lokwengame iNingizimu Afrika kuvamise kwenta bantfwana babe bahlukunyetwa.

Iminyaka leminengi Lihhovisi Lemmeli Wemndeni (i-OFA) lente kutsi kubekhona kufinyelela mahhala bulungiswa bebantfwana labasengotini, labangakwati kutivikela. Ihwala ngu-Advocate Petunia Seabi-Mathope, i-OFAibekwengekhatsi kuLitiko Letebulungiswa Nekucondzisa Kwsimilo. Isebenta njengemmeli lokhetsekile longavunicala, wemndeni futsi longumeluleki wenkantolo wemacala embango mayelana nelilungelo lekugcinwa kwebantfwana kanye nelilungelo lekuba ngumtali. Iphindze futsi ibhale phasi tinhlelo tekuba ngumtali, ihhole simo semntfwana sengcondvo ibambisene nabosonhalakahle ibuye futsi ingenelele emkhatsini wemindeni lapho khona kunakekelwa kwebantfwana kusenkingeni.

"Indzima yetfu lenkhulu lesiyidllako kuvikela nekukhutsata kwentiwa kakhulu kwalokufanele kwebantfwana eNingizimu Afrika.

"Lokubakhona kwemahhovisi etfu kuhombisa kubona nekwemukela kwaHulumende waseNingizimu Afrika kutsi nembala bantfwana babalulekile kwelive futsi sikhombisa kutimisela kuvikela emalungelo ebantfwana labasengotini ngekweamtsetfo wetenhlaho netivumelwane temave emhlaba iNingizimu Afrika lekfanele kutsi itigcine," kusho Advocate Seabi-Mathope. Le-OFA, legubha umkhosi wayo wekubakhona we-25 kulomnyaka, ekucaleni beyinemandla lanemkhawulo futsi emahhovisi ayo bekasetindzaweni letitsite nje kuhela.

Ngekungenisa kweMtsetfo Webantfwana, wanga-2005 (Umtsetfo We-38 wanga-2005), tinsita te-OFA tentiwa tatfolwa nguwonkhe

mntfwana kulelive, kufaka ekhatsi bantfwana labagacele etincabanweni tekondla nebudlova basekhaya.

"Sacala sinemahhovisi ebameli bemndeni lasitfupa nje kuhela, lamuhla sinemahhovisi lange-25 nebameli labange-90 kulo lonkhe lelive, siphindze futsi sibukane nemacala langasiwo wenkatolo ngekutsi sinikete tinsita tefu tekungenelela," kwasho Adv Seabi-Mathope. Licala lelingesilo lenkantolo licala lapho lelitekwa libuye lincunywe ngaphandle kwenkantolo, futsi lifaka ekhatsi bufakazi lobunika ngumntfwana. Loku kusita ngetindlela letintyeni kunciphsa lizinga lekusalela emuva kwemacala enkantolo. Kusita iminden ngalokuchubekako i-OFA seyente emahhovisi ayo aba ngulenta iminden nebantfwana bakhibile, bantfwana nemindeni bative baphephile, lokwenta i-OFA kutsi yente umsebenti wayo kahle futsi ngemphumelelo. Sibonelo sendlela leyenta umntfwana akhibike leyefulwe yi-OFA yiKhithi Yemathulusi Yemntfwana. Ngembi kwekusetjentiswa kwalekhithi bosonhalakahle bebabuta bantfwana imibuto lebalulekile lemayelana nelimuva nendlelamphilo yakhe, Iwatiso lolubalulekile kunoma ngabe nguliphi licala letemtsetfo, nanoma kunjalo bekuyinsayeya kwenta bantfwana bakhulume nemuntfu labangamatni ngetindzaba telingansense labo nemiva.

Kwentiwa kwalekhithi, lokufaka ekhatsi tincwadzi labatifa imibala, emakhrayoni, titfombe temindeni nebangani letinemuza, emkhatsini waletinye tintfo, kunika lomntfwana emathulusi ekuphendvula imibuto yasonhlalakahle ngaphandle kwekutiva esatjiswa. "Lokutfolakele ngayo kuhle kakhulu futsi kwengeta sisindvo kulelical," kusho Adv Seabi-Mathope.

OFFICE OF THE FAMILY ADVOCATE PROTECTING THE BEST INTERESTS OF CHILDREN

There are thousands of children in the country who are affected everyday by legal custody battles, mediation or child abduction. These circumstances make children vulnerable and affect them in many ways. The Office of the Family Advocate, located in the Department of Justice and Constitutional Development, is driven by the need to protect the rights of children whose parents are in dispute.

A FAMILY RESTORED

Two young siblings from Mabopane in Gauteng now have a chance to live a healthy and happy childhood due to the assistance from the Garankuwa district Office of the Family Advocate (OFA).

Simphiwe Lamola (7*) and his younger sister, Namhla (5) were recently reunited with their father, Ernest Lamola, who sought assistance from the OFA. The children had been in the custody of their mother, Siphokazi, after the couple split in 2013. During this time, Simphiwe and Namhla did not attend school regularly.

Fearing she would lose her children, Siphokazi was assured by the family councilor that the mediation between her and her ex-husband would ensure that the wellbeing of the children would be put first. Both parents agreed to work out a way to best support and meet the best interests of their children together.

A mediation session was held by the Office of the Family Advocate. The matter was resolved by the parents, with the assistance of the councilor, within a few hours. As a result, the children are now living with their father, and visit their mother regularly.

WHAT IS THE OFFICE OF THE FAMILY ADVOCATE?

A Family Advocate is an unbiased Family Law specialist who assists parental parties to reach an agreement on disputes regarding the care and contact of children through mediation.

YOU MAY CONSULT THE OFFICE OF THE FAMILY ADVOCATE IF:

- There is a dispute regarding contact or care of a child.
- A person wants to draft a parental rights and responsibilities agreement.
- They want to register their parental rights and responsibilities agreements.
- A person wants to amend or terminate parental rights and responsibilities agreements registered with the Family Advocate.

- There is a dispute on whether the unmarried father of the child born out of wedlock has satisfied the requirements which makes him eligible to acquire full parental rights and responsibilities in terms of the law.
- Courts also make orders that the Family Advocate has to conduct an inquiry as to what is in the best interest of the child.

The Family Advocate can amend or terminate parental rights and responsibilities agreements registered by the Family Advocate's office. This means that the parties do not have to go to court if they want to amend the agreement when the need arises.

In the process of consulting, if the parties reach agreement on disputed issues the matter does not proceed to trial, thereby saving legal costs and time.

Courts or Judicial Officers are required by law to consider the report and/or recommendations of the Family Advocate when making a decision as to what is in the best interest of the minor child.



Courts will not readily give a decree of divorce where there is a dispute regarding minor children without the report or recommendations of the Family Advocate.

Parental rights and responsibilities agreements or parenting plans registered with the Family Advocate have the same legal effect as an order of court.

QUICK FACTS

- The Family Advocate cannot become involved in any matter that has already been finalised by the Court.
- The Family Advocate cannot be subpoenaed to Court as a witness to give evidence on behalf of any party even if his/her recommendation is in favour of that party.
- The recommendation of the Family Advocate is intended to assist the Court in adjudicating a matter and arriving at a particular order. The recommendation itself is not enforceable unless incorporated in a Court Order.
- The Family Advocate is a neutral institution and cannot act as a legal representative.
