

Ravele yi vekisa ntswalo eka dyondzo

Ntswalo lowu humaka eka ku xavisiwa ka ntsho-velo wa Khamphani ya Miako wa Muganga wa Ravele (CPA) wu averiwa vavuyeriwa na nhlangano lowu. CPA yi tlhele yi tumbuluxa nkama wa timali lowu pfunaka 40 wa swichudeni etiyunivhesithi to hambanahambana etikweni hinkwaro.

Va endla swiyenge swo hambanahambana swa tidyondzo eYuni-vhesithi ya Doroba ra Kapa, Yuni-vhesithi ya Kapa-Vupeladyambu, Yunivhesithi ya Doroba ra Nelson Mandela, Yunivhesithi ya Joni, Yunivhesithi ya Free State na Uni-vhesithi ya Sayense ya Rihanyo ya Sefako Makgatho, leswi nga na nxavo lowu katsaneke wa R410 000 hi lembe.

Dakalo Nemauluma hi wun'wana va vavuyeriwa wa nkama lowu. U endla Digiri ya Masitasi

ya Sayense ya Vuinhiniyara bya Tikhemikhali eYunivhesithi ya Doroba ra Kapa.

Nemauluma, loyi a humaka evuswetini, u vula leswaku u khensa swinene nseketelo wa CPA. "Vatswari va mina a va tirhi na-swona vo kuma switirhwatirhwani nkarhi na nkarhi leswaku va kota ku endla swilo leswi va ti hanyisa-ka ha swona.

"Ava na mali yo ringana yo ndzi hakelela tihakelo ta le yunivhesithi naswona ndzi tshembha leswaku ndzi ta kota ku heta digiri ya mina ya Masitasi eku heleni ka haxawa leswaku ndzi ta kota ku va pfuna leswaku va huma evuswetini lebyi va nga hanya ka byona ku suka evuhlangini bya vona."

U tirhisa mali ku suka eka CPA ku fikelela nxavo wa vutleketli, tidyondzo, vutshamo, swakudya na tibuku. "Pfuno lowu wa timali wu ndzi pfunile swinene naswona hi tindlela to hambanahambana ku

suka emikarhini leyi a ndzi nga ri-na mali yo ringana ya vutshamo, vutleketli na tihakelo ta yuni-vhesithi. Xiave lexi xi endliweke hi pfuno lowu wa timali i xa nkoka swinene."

CPA yi tlhela yi pfuna vadyondzi vo antswa va ka Giredi 12 emugangeni laha mudyondzi wo antswa a nyikiwaka R3 000. Vadyondzi lava khomaka xiyimo xa vumbirhi, xa vunharhu, xa vumune ni xa vunlhunu va kumaka R2 500, R2 000, R1 500 na R1 000, hi ku landzelana.

"Xikongomelo i ku va khutaza ku tiva leswaku ku ni hakelo loko u tirha hi ku chirikira ni ku ti karhaka. Hi tlhela hi hlawula ku suka embiteni yin'we ku pfuna vanhu lava nga ta ya eyunivhesithi lembe leri

landzela-ka." □

Khamphani ya Miako wa Muganga ya Ravele eLevubu, Limpopo, wu kumile 16 wa mapurasi ya timakhadamiya, mahafukhada, tibana, mihlata na tinombhela leswi nga ni nxavo wa R42 miliyoni ku suka eka mfumo hi 2005.

Ejensi leyi vuriwaka Vafambisi ya Mapurasi ya Afrika-Dzonga (SAFM) yi fambisa purasi leri. Ntirhowa ejensi leyii ku dyondzia miganga ku tirhisa misava leyi koxiweke hi ndlela leyi vuyerisaka.

Hi 2007, Danie Basson u thori-wile tanihu Muofisirinkulu wa Vuhumelerisi wa SAFM.

Bethuel u ri CPA na SAFM a yi nga twanani eka timhaka to hlaya mayelana ni mafambiselo ya purasi leri.

CPA yi nyikile Basson kotiraka ya tinhewti ta ntsevu naswona hi nkarhi lowu wa ntsevu wa tinhewti u tirhile ntirho wa xiyimo xa le henbla epurasini leri. "U tumbuluxile tindlela ta vuhumelerisi leti nyikeke tiyuniti leti vutomi naswona hi ku landzelela matirhelo ya yena ya xiyimo xa le henbla, hi tekile xiboho xo n'wi nyika kotiraka ya malembe ya ntlanhu."

"Government is determined

to improve the business environment by lowering the cost ... and improving the ease of doing business."

President Zuma said provincial One Stops would also be launched this year.

"These will be known as InvestSA KZN, InvestSA Gauteng and InvestSA Western Cape and so forth as we roll our new Invest SA brand. Other provinces will open their One Stop Shops over a

period of three years."

Investors get one point of contact

For investors the InvestSA One Stop Shops will be the main point of contact with government. They will help

investors to work with the relevant government departments involved in issuing permits and in regulatory, registration, and licensing

MAENDLELO LAMANTSHWA YA dyondzo ya mirhi ya komba leswaku ku na swidzidziharisi leswi nga kona swo tshungula Rifuva (TB) leyi sihalalaka, swidzidziharisi swo hambanahambana na swidzidziharisi leswi ndlandlamukeke. Afrika-Dzonga i mutirhisinkulu emisaveni hinkwayo wa xidzidziharisi xintshwa lexi vuriwaka *Bedaquiline*.

Phurogireme ya Vufike-lera bya Xitliniki bya *Delamanid* yi lavisia swidzidziharisi swintshwa leswi nga ta tirhisiwa ku tshungula Vuvabyi bya Rifuva lebyi Sihalalaka Swidzidziharisi (MDR-TB) ni ku fambisa ni ku tshungula TB eAfrika-Dzonga. Holobye wa Rihanyo Dok. Aaron Motsoaledi a hi khale a kombisile phurogireme leyi eXibendlhele xa Vuvabyi bya Ndhongho xa Sizwe eGauteng.

Mbuyelo wukulu wa swidzidziharisi leswi hileswaku swi ni sihalalo wuntsongo naswona swi ni matimba ku tlula mirhi yin'wana ya TB.

"Swi tirha hi ku hetiseka ngopfugopfu eka vana, vuvabyi bya HIV na vuvabyi bya chukela naswona ley i mitlawankulu ya vavabyi lava swi tikaka ku va tshungula hi ku hetiseka."

Ejensi ya Mirhi ya le Yuropo yi pasisile xidzidziharisi lexi in 2014 ku tshungula MDR-TB ya mahahu. Sweswi swi hangalasiwile eka 45 wa matiko ni ku tlula 2 100 wa

Holobye Motsoaledi u vule leswaku ndzawulo ya yena yi fikelerile ku pasisiwa ka xidzidziharisi lexi ku suka eka Khanisele ya Vulawuri bya Mirhi (MCC) ku endla leswaku xidzidziharisi lexi xi kumeka ro sunsgula eka 400 wa vavabyi eGauteng, KwaZulu-Natal, N'walungu-Vupeladyambu na Kapa-Vupeladyambu tani hi xiphemu xa phurojeke ya vulavisi.

TB ya tshunguleka

Dok. Motsoaledi u vule leswaku TB i xidlayinkulu eka mavabyi yo tlulela.

"TB ya tshunguleka, ngopfungopfu loko yi amukela swidzidziharisi ni ku voniwa hi nkarhi. Hambiswirito, hi vona ku tlakuka

loku vavisaka mbilu ka TB leyi sihalalaka swidzidziharisi."

U vule leswaku TB leyi sihalalaka xidzidziharisi yi le ku tlakueni naswona yi le ku hangalakeni eka vanhu lava a va nga ri na TB, leswi vulaka leswaku DR-TB yi le ku khomeni ka vanhu hi tindlela ta ntolovel.

"DR-TB a yo tika ku yi tshungula ntsena, loko ku langutiwa ku ya ehansi ka tindlela to yi tshungula hi ku hetiseka, swi tlhela swi durha swinene. Vatirhi eka Ndzawulo ya Rixaka ya Rihanyo va ehleketa leswaku loko swi durha kwalmuya ka R400 ku tshungula mavabyi loyi a nga khomiwa hi TB leyi sihalalaka xidzidziharisi, leswi swi durha mikarhi ya 1 000 ku tshungula MDR-TB na mikarhi ya 2 000

ku tshungula XDR-TB."

Afrika-Dzonga ri tsarisa kwalmuya ka 13 000 wa MDR-TB na 1 000 wa vavabyi lava hlaseriwa hi (XDR) TB ya sihalalo lowu ndlandlamukeke lembe na lembe. U vule leswaku ku ni swivangelo swo hlaya leswi nga ni xiave eku sihalaleni ka swidzidziharisi swa TB, ku katsa ni ku hlwela ka ku vona vukona bya yona, vutinyeketi bya le hansi bya vutshunguri, vulawuri bya xiyimo xa le hansi bya ku khomiwa hi mavabyi lawa, naswona, xa nkoka i ku pfumaleka ka swidzidziharisi swintshwa.

Bedaquiline ya tirha

"Nhlamulo ya vutshunguri bya TB yi simekile timitsu ta yona eka swidzidziharisi leswi thumbhiweke ku tlula malembe ya 50 lama hundzeke. A hi khale ku thumbhiwile xidzidziharisi xintshwa ya TB, Bedaquiline, lexi tumbuluxiweke eAfrika-Dzonga. Afrika-Dzonga ri endlile xidzidziharisi lexi hi xihatla, naswona hi endla 60 wa tiphesente eka matiko lama nyikaka vavabyi va wona xidzidziharisi lexi."

"Sweswi vuxokoxoko byo sunglela byi komba mimbuyelo yo antswa

exikarhi ka mitlawa ya vavabyi lava kumaka xidzidziharisi lexi, laha ku humelela ka vutshunguri ku tlulaka 70 wa tiphesente, loko ku piminyisiwa na 50 wa tiphesente ta vavabyi lava kumaka vutshunguri bya xidzidziharisi xa ntolovel.

Dr Motsoaledi u vule leswaku phurogireme ley i xinakulobye exikarhi ka Ndzawulo ya Rihanyo, Otsuka na Mfanelo yo Tekela Nhlokweni. Otsuka i khamphani ya le Japani ley i endlaka xidzidziharisi xi kumeka mahala.

Vanhu lava khumbhekaka ngo-pfu hi ntungu wa TB i vatirhi va le migodini, miganga ya le migodini na mindyangu ya vona, vatirhi va le makhotsweni, matikoxikaya ya le kule, miganga ya le mapurasini na swikolo swa yona, miganga ya le kusuhu na migodi na vukorhokerhi bya le makhotsweni ku katsa na tisenthara ta dyondzo ya le hansi.

Dok. Motsoaledi u vule leswaku u tshembha leswaku vavabyi va le Sizwe na swibendlhele swin'wana etikweni hinkwaro va ta vuyerihi hi phurogireme ley i kutsa na mapfhumba yan'wana lama mfumo wu nga le ku ma humeleriseni.

The business community has welcomed the newly launched InvestSA One Stop Shop initiative.

Derrick Huang, managing director of international company Beyond Your Dreams (BYD) South Africa, says the concept of the one stop shop will make their lives as investors a lot easier.

This Chinese firm is primarily an IT and renewable energy company. It is listed on the Hong Kong and New York stock exchanges and has over 200 000 employees internationally.

"Invest SA is so nice. I know how difficult it is to have your visa or work permit extended in South Africa. This one stop shop will make things so much easier. China and South African relations are at an historical high. We are in the G20 and in Brics there are good things going on between the two countries."

Huang said BYD had big plans for

the South African market especially because BYD was into battery power storage, electric motor vehicles and the manufacturing of cell phones and tablets.

"We have done some business in South Africa. ... We are now really making entrance in South Africa. We are very fortunate to come into the market when things are made much easier for us as investors."

Launching InvestSA President Jacob Zuma said The One Stop Shop will provide a more coordinated, streamlined and professional service to those who wish to set up a business," President Zuma. V

processes.

Officials were instructed to keep the service simple and short.

Key departments such as home affairs, labour, environmental affairs, trade and industry and agencies such as the Companies and Intellectual Property Commission (CIPC), South African Revenue

Service and Eskom amongst others will be available at the One Stop Shops.

President Zuma said: "Business people have outlined the difficulties and hassles they face when wanting to establish new businesses, both local and foreign investors." The President also said the CIPC has rolled out self-service terminals in banks,

local economic development agencies and chambers of commerce offices for company registrations. By June this year self-service terminals will be rolled out to all provinces.

President Zuma said the the One Stop Shop's success will depend on the support of all stakeholders in the three spheres of government. V
